### New Arrangements on Dissemination of Corporate Communications

Shareholders are encouraged to subscribe for the News Alert service provided by HKEX (currently at <a href="www.hkex.com.hk/eng/invest/user/login\_e.aspx">www.hkex.com.hk/eng/invest/user/login\_e.aspx</a>). Through the News Alert service, subscribers will receive alerts when the Company publishes regulatory notices on the HKEXnews Website or when disclosure of interest filings are made in respect of the Company.
